5	Deacon Juan Francisco Hinojosa	6/25/1993	Never ordained; laicized 1996	Archdiocese of Chicago first learned of allegations against Hinojosa when he was arrested and charged on June 25, 1993.
6	Rev. Thomas Barry Horne	2/3/2004	Deceased (1985)	Cleric was deceased before first allegation received.
7	Rev. John Jordan	7/9/2002	Deceased (1987)	Cleric was deceased before first allegation received.
8	Rev. George Klein	8/16/2011	Retired and faculties withdrawn	Allegation unsubstantiated by Archdiocese of Chicago Independent Review Board.
9	Rev. Patrick Lee	1/9/2019	Withdrawn Pending Investigation	Currently withdrawn from ministry pending investigation.

10	Rev. Robert Lutz	9/20/1988	Deceased (2006)	Civil lawsuit against Lutz proceeded to jury trial where jury returned unanimous verdict in favor of Lutz in 1994. Subsequent allegations were not submitted to the Archdiocese of Chicago Independent Review Board because the person making the allegation refused to come forward, withdrew their allegation, or the cleric was deceased at the time the allegation was received.

12	Rev. Octavio Munoz-Capetillo	7/28/2015	Withdrawn Pending Criminal Investigation	Currently withdrawn from ministry pending investigation.
13	Rev. Michael O'Connell	12/2/2013	Active	Allegations investigated by civil authorities, unfounded by DCFS and unsubstantiated by the Archdiocese of Chicago Independent Review Board.
14	Rev. Thomas O'Gorman	8/10/1992	Resigned (1994)	Allegation was reported to DCFS and unfounded.
15	Rev. Patrick O'Leary	9/28/2004	Faculties withdrawn; Returned to home diocese in Spain.	Extern priest serving in the Archdiocese of Chicago. Allegations unsubstantiated by the Archdiocese of Chicago Independent Review Board.
16	Rev. Paul O'Toole	Allegation did not relate to abuse of a minor.	Deceased (2017)	Resigned from priesthood before first allegation received.
