



### MEMORANDUM

In attempts to follow up on information provided by  in his allegation of sexual abuse against the former Rev. James Hagan, I called and spoke with Sr. Elizabeth Lynch, OP on March 22, 2007. Sr. Elizabeth was principal of St. Denis at the time of the alleged abuse by Fr. Hagan. When asked, Sr. Elizabeth informed me that Ms. Ellen Murphy was a former school secretary at St. Denis. Sr. Elizabeth provided Ms. Murphy's contact information of .

I called and spoke with Ms. Murphy via phone today. After introducing myself, I informed Ms. Murphy that Sr. Elizabeth had provided me with her name and contact information. I then provided Ms. Murphy with a brief verbal description of my office and reason for the phone call. When asked, Ms. Murphy stated that she would be willing to speak with me. Prior to continuing, I informed Ms. Murphy that this was a confidential matter.

I asked Ms. Murphy if and when she was a school secretary at St. Denis. Ms. Murphy stated that she was a school secretary there for seven years and that she left in October 1992. I informed Ms. Murphy that the allegation that I was investigating was made against the former Rev. James Hagan. I then asked Ms. Murphy if there was ever a practice where she would call students out of the classrooms either through the PA system or in a different matter to come to the school office. Ms. Murphy stated that it would have been "unlikely" for her to call for a student to come to the office via the PA system. She stated that there were occasions when she would have gone to a classroom to get a child if the child's parent had called the office in an emergency type situation. I then asked Ms. Murphy if Fr. Hagan or any other priest ever asked her to call a child out of a classroom to come to meet with him. Ms. Murphy stated that Fr. Hagan never asked

her to call a child out of class for him. She also stated that it would have stood out in her mind if that did happen [Fr. Hagan ask her to call a child out of class] or if she observed something like that.

I thanked Ms. Murphy for her assistance. When asked, Ms. Murphy stated that she did not need my name or contact information.



Having received the recommendation of the Archdiocesan Professional Responsibility Review Board that information at least seems to be true that **James Hagan**, prior to his resignation from priestly ministry, engaged in sexual misconduct with [REDACTED] a minor at the time of the alleged incident, I have concluded that this constitutes information which "at least seems to be true" (c. 1717).

Therefore, in accordance with the aforementioned canon, I decree that an inquiry be done into the facts and circumstances of this accusation, as well as its imputability to **James Hagan**.

Since my other duties prevent me from conducting this investigation personally, I hereby appoint **Ms. Leah McCluskey** to act as the investigator in this matter. In carrying out these duties, Ms. McCluskey will have all of the authority of an auditor, in accordance with cc. 1428 and 1717. She is to collect any additional proofs she deems necessary in accordance with the norm of law as they relate to the present allegation. She is delegated to take testimony from the accused and from any witnesses (cc. 1530 – 1538 and 1547 – 1573), to obtain any necessary documents (cc. 1540 – 1546), to enlist the services of any experts deemed necessary (cc. 1574 – 1581), and to have access to places or things which she deems necessary for her investigation.


In conducting her investigation, Ms. McCluskey is to take care that such an investigation does nothing to harm James Hagan's name or to violate his right to protect his privacy.

Mr. James Hagan contacted Fr. Tivy at the Vicar for Priests Office via phone at 2:00pm for the scheduled interview. The interview was conducted entirely via speakerphone.

After introductions were made, PFRA described the responsibilities of the Office of Professional Fitness Review as well as those of PFRA. PFRA also explained the Review Board process to Mr. Hagan. As PFRA prepared to read the allegation of sexual misconduct made by [REDACTED] Mr. Hagan agreed to interrupt PFRA if he was unclear with any information that was being read to him.

Mr. Hagan did not speak as PFRA read [REDACTED] allegation of sexual misconduct to him. Upon the conclusion of PFRA reading the allegation, Fr. Tivy asked Mr. Hagan if he chose to respond. Mr. Hagan's response was, "He [REDACTED] is somebody that I knew and I have no comment to make."

Fr. Tivy agreed to contact Mr. Hagan when this matter will be presented to the Review Board.

### Victim Statement Abstract

This abstract replaces the summary prepared by Leah McCluskey, Professional Responsibility Administrator for the Archdiocese of Chicago's Office of Professional Responsibility, of Victim AY's statement, given to Ms. McCluskey on March 14, 2003, formalizing his allegation of abuse against Rev. James Hagan. The alleged abuse consisted of fondling and oral sex. The alleged abuse occurred from approximately 1982 to 1986, occurring roughly once a month between the time Victim AY was 14 and 18 years old. The alleged abuse occurred at St. Richard's parish, St. Gertrude's parish, at a movie theater, and once during an out-of-state trip to an amusement park where he was forced to share a bed with Hagan. Victim AY also recalls Hagan having groups of kids watch R-rated movies in the rectory. Victim AY reported that Hagan invited him to go on outings and then back to the rectory approximately once per month.

Dear Cardinal George

As you recall I informed you in April last year that Father James Hagan molested me when I was a youngster at St. Catherine/St. Lucy parish. Just last month Leah McCluskey from the Archdiocese told me that the review board determined that my allegation is true. It was extremely consoling for me to hear that the Church believed me.

I am asking you to go with me to every parish where Father James Hagan served to invite other victims to come forward to get healing. Other victims of Father Hagan may never come forward if they do not hear from you. Your joining me and speaking at those parishes may empower other victims of Father Hagan to come forward for support and comfort and to begin a journey of healing in their lives.

I am also asking that you immediately release the names of all priests who have been found by the archdiocesan review board to have been perpetrators of sexual abuse. It is important for two reasons: 1) So that all those abused will know they are not alone and that they may come forward to get healing and 2) So that no more children are abused by these men. The adults surrounding the perpetrators need to be put on notice so that children will not be allowed around these perpetrators. Children are at risk and won't be if you, Cardinal George, make their names public.

Despite the disclosures that occurred about the clergy abuse crisis in 2002, many people in the church still have not seen enough action on the part of church leaders to protect children and to search for other victims of priest abuse.

### **Phone Interview**

James Hagan [JH] contacted Fr. Tivy [VP] via phone at 10:00am from the Vicar for Priests Office for the scheduled appointment. PFRA apologized for arriving for the appointment approximately 20 minutes late. After introductions were made, PFRA described the responsibilities of the Office of Professional Fitness Review as well as those of PFRA.

PPFA then continued by reading the allegations of sexual misconduct made by [REDACTED] against JH. JH stated that, "The name [REDACTED] doesn't ring a bell" and has not become any more familiar to him throughout the past five weeks [since being notified by VP of the allegation].

JH stated that he has "absolutely no memory of this incident or of having [REDACTED] eighth graders in my room." He again clarified that "I definitely don't remember him [REDACTED] or the incident that he described." JH described the rectory of St. Catherine/St. Lucy as "an open place" where there was "much interaction." However, "[having [REDACTED] boys in his room] during school time doesn't click at all." JH then stated, "I believe that I would remember this [details of [REDACTED] allegation]... I think that I'd remember what he's describing."

JH stated that it is a “great possibility” that [REDACTED] was in his room due to the fact that [REDACTED] knew that JH had a [REDACTED] “in his [JH’s] possession.” JH then described his room as including a love seat and two chairs. JH “questioned” having [REDACTED] people in his room [besides himself]. As per JH, if there were [REDACTED] other people in his room, “I would be sitting next to one.”

PFRA then explained to JH the Review Board process. JH is aware that VP will notify him when this allegation and response will be presented to the Board. JH was extremely cooperative during the mentioned phone conversation.





In anticipation of (your) meetings with the parish staff and the pastoral council at St. Denis Parish, I am writing to provide you with information regarding the matter of Father James Hagan.

The Professional Fitness Review Board conducted a Second Stage Review on Wednesday, August 21, 1996. This was in keeping with Archdiocesan policies and procedures which provide that such a review shall ordinarily be initiated and scheduled to occur no earlier than 30 and no later than 120 days after completion of the First Stage Review. Father Hagan's First Stage Review was completed on April 22, 1996.

In light of all the information gathered and reported by the Professional Fitness Review Administrator at the Second Stage Review, the Board determined that it is not reasonable to return Father Hagan to ministry and recommended that his withdrawal from ministry continue. Cardinal Bernardin has accepted this determination and recommendation. The people of St. Denis Parish should be informed of this decision. They should also be informed that Cardinal Bernardin has accepted Father Hagan's resignation as pastor of St. Denis Parish.

The Cardinal has expressed his concern for Father Hagan, for those who brought the allegations, and for all the people of St. Denis Parish. He acknowledged that this is a time of grief in many respects. Mindful of the pain and hurt being felt at this time, the Cardinal expressed his hope that true healing may come to Father Hagan and to all involved in this process.

**QUESTIONS & ANSWERS CONCERNING

- Q: When did the Archdiocese first learn of these allegations?
- A: The allegations were first made to an archdiocesan priest on April 19. He immediately contacted the Archdiocese of Chicago's Vicar for Priests Office, which immediately contacted the Office of the Professional Fitness Review Administrator.
- Q: Was the allegation made by calling the toll-free 800 number?
- A: No, not in this instance.
- Q: What is the nature of the allegations?
- A: More than one adult male has alleged that Father Hagan engaged in inappropriate sexual behavior with him while he was a minor.
- Q: When did the alleged incidents occur?
- A: According to the allegations, the incidents occurred during the early to mid-1980s while Father Hagan was an associate pastor at St. Richard Parish.
- Q: Has the Archdiocese informed the Cook County State's Attorney's Office and/or the Illinois Department of Children and Family Services?
- A: Yes. Archdiocesan officials notified both the Cook County State's Attorney's Office and DCFS of the allegations on April 24.
- Q: Did the Archdiocese offer help of any kind to the individuals making the allegations?
- A: Yes. Archdiocesan Assistance Ministers have met with them. It is the policy of the Archdiocese to offer appropriate help.
- Q: What is Father Hagan's status with the Archdiocese?
- A: He has been withdrawn from his assignment at St. Denis and been placed on

administrative leave.

Q: Where is Father Hagan now?

A: He is in a monitored setting.

Q: How long has Father Hagan been a priest?

A: He was ordained in 1974. He has served as pastor at St. Denis Parish since June, 1988. His other assignments include:

1974-81	Associate Pastor, St. Catherine of Siena, Oak Park
1981-86	Associate Pastor, St. Richard
1986-88	Associate Pastor, St. Gertrude

Q: How would I send a letter to Father Hagan? Where should I send it?

A: Send it to Rev. James Hagan c/o Vicar for Priests Office, Archdiocese of Chicago, 645 N. Michigan Ave., Suite #543, Chicago IL 60611.

Q: Were the alleged victims parishioners at St. Richard or St. Denis?

A: At their request and for reasons of confidentiality, we have identified the individuals as adult males, period.

Q: Has Father Hagan's case been reviewed by the Review Board?

A: Yes. A First Stage Review meeting was held by telephone conference call on April 22. The Review Board concurred with the actions taken by the Archdiocese and the recommendation to withdraw Father Hagan from parish ministry pending further inquiry according to archdiocesan policies and procedures.

Q: Has the Archdiocese alerted parish leadership at other parishes where Father Hagan was assigned?

A: Yes.

Q: Will parishioners be notified of these allegations? How and when will parishioners be notified?

A: Parish leaders and parishioners have been notified in various ways.

Q: Have there ever been prior allegations involving Father Hagan?

A: Yes. One allegation in 1988 was determined to be unfounded by DCFS and the Cook County State's Attorney's Office.

### Victim Statement Abstract

This abstract replaces the summary prepared by Leah McCluskey, Professional Responsibility Administrator for the Archdiocese of Chicago's Office of Professional Responsibility, of Victim BD's statement, given to Ms. McCluskey on May 27, 2004, formalizing his allegation of abuse against Rev. James Hagan. The alleged abuse consisted of fondling, masturbation, and one incident of oral sex. The alleged abuse occurred at St. Catherine's parish, St. Richard's parish rectory, and in Fr. Hagan's car. The alleged abuse began when Victim BD was in sixth or seventh grade and continued until he was approximately 18 years old between approximately 1975 and 1980, and occurred during counseling sessions with Fr. Hagan. Victim BD also reported that he stayed overnight in the rectory numerous times over a period of several years, and that other priests at St. Catherine would see Victim BD entering and leaving Hagan's room. Victim BD also reported that he smoked marijuana in St. Catherine's rectory when other priests may have been in the building.

PRA spoke with Rev. John J. Carolan via phone today in connection with the investigation of  allegation of sexual misconduct against the former Rev. James Hagan. Fr. Carolan was assigned to St. Catherine of Siena/St. Lucy in Oak Park with Fr. Hagan from 1977 through 1981. Fr. Carolan was ordained in 1951 and is currently retired, residing at St. Catherine of Siena/St. Lucy.

PRA began by briefly informing Fr. Carolan of the purpose and function of the Office of Professional Responsibility. When he was told that the phone call was in connection with an investigation of an allegation against a priest who was assigned with him at St. Catherine of Siena/St. Lucy, Fr. Carolan immediately indicated that he knew it was about Fr. Hagan. When asked if he had a few minutes to talk this morning, Fr. Carolan indicated that he did.

When asked, Fr. Carolan stated that he never observed an inappropriate behavior on the part of Fr. Hagan while they were assigned together. He added that is the reason why it was such a complete surprise to him when the allegations against Fr. Hagan first surfaced. When asked, Fr. Carolan stated that he never saw Fr. Hagan with any minor boys in his room at all and/or any inappropriate behavior with minors. Fr. Carolan shared that Fr. Hagan was a good photographer and used to take pictures of "...the kids playing..." and that he was artistic. However, Fr. Carolan never saw Fr. Hagan behave inappropriately with and/or around minors. When asked by PRA, Fr. Carolan stated that he never knew of/saw Fr. Hagan spend one on one time with minors in a therapeutic or mentoring capacity.

PRA then asked Fr. Carolan if he ever knew of Fr. Hagan abusing any substances such as alcohol or marijuana. Fr. Carolan stated that Fr. Hagan never drank alcohol and that he was opposed to drinking. He stated that Fr. Hagan was not even a cigarette smoker and was unaware of any suggested substance abuse [smoking marijuana].

Reminding Fr. Carolan that this investigation was confidential, PRA asked if he would feel comfortable being told the name of Fr. Hagan's accuser [to determine if he remembered the boy and/or his family]. Fr. Carolan agreed to have PRA reveal the identity of the alleged victim. When PRA shared [REDACTED] name with Fr. Carolan, he immediately indicated that he knew him and his family. Fr. Carolan stated that the [REDACTED] Family was a part of St. Catherine of Siena/St. Lucy parish and that Fr. Hagan was "...very close to the family." [REDACTED]

PRA thanked Fr. Carolan for his time, assistance, and cooperation this morning. Fr. Carolan was asked to call PRA at any time with any questions or concerns.

In a 9-0 vote, in light of the information presented, the Board determined that this matter warrants additional investigation. The Board also made the following recommendations:

- That PRA speak with Archdiocesan attorneys regarding the issue of victims/survivors [represented by attorneys] not fully cooperating with the process of one formalizing his/her allegation. Specifically, PRA is to discuss with Archdiocesan attorneys the growing issue with victims/survivors not signing the final report of their formalized allegation.
- That PRA attempt to obtain a signature from [REDACTED] on his final report.
- That PRA write a letter to Mr. Hagan encouraging that he provide a signature and/or comments on the draft report written [by PRA] summarizing his response to [REDACTED] allegation against him.
- That PRA attempt to obtain personal information on [REDACTED] including how long he has been in Hong Kong, current family situation [i.e. married?, children?], etc.
- That PRA determine if [REDACTED] at any time in the future, when PRA could meet with him face to face.
- That PRA ask [REDACTED] if he can be more specific with the dates/time frames that he stayed in the rectory with the former Fr. Hagan.
- That PRA ask [REDACTED] to provide a description of the rectory where he stayed with Fr. Hagan, as well as for [REDACTED] to state where in the rectory he stayed, what types of activities Fr. Hagan engaged him in, and what types of movies Fr. Hagan had for them to watch.
- That PRA ask [REDACTED] the circumstances as to how he was able to come forward with his allegation at this time.
- That PRA determine if any of the other priests assigned with Mr. Hagan during the time of the alleged abuse of [REDACTED] are still alive. If so, for PRA to speak with those priests regarding Fr. Hagan.





Per our discussion, I am following up on your letter of October 15, 2003 regarding the above matter. I have passed your correspondence on to Ms. Leah McCluskey, the Professional Responsibility Administrator of the Archdiocese of Chicago. It is my understanding that she has been in contact with you about this matter. As you know, either you or your client can contact Mr. Ralph Bonaccorsi (312-751-8293), Assistance Minister of the Archdiocese, for therapy from a licensed therapist selected by your client at the Archdiocese's expense while this matter is being processed.


We would also note that, on September 19, 1996, [REDACTED] notified the Archdiocese that he had been abused by an Archdiocesan priest. He said that [REDACTED] Although [REDACTED] did not name the priest who was the perpetrator, he said that he wanted to make sure that the priest was receiving help with his problem and that he was in a place where he could not harm anyone else. He described the priest as "more than my molester, he was a good teacher and another soul struggling to come to terms with life, and a friend (albeit dysfunctional)" and said that he wanted to "share my feelings and thoughts [with the perpetrator] (I think we can help each other heal ... at least somewhat." When [REDACTED] came forward again in October 2003, we learned that the priest was Father Hagan, who resigned from the priesthood on March 31, 1997.

Dear Sister Nora:

I am in receipt of the copy which you sent me of your letter of October 11, 1996 to Cardinal Bernardin, regarding Fr. James Hagan. As the Cardinal's Delegate to the Professional Fitness Review Board, which recommended Father Hagan's withdrawal from St. Denis Parish, I must express my objection to your letter.

It is simply wrong for you to assert that Cardinal Bernardin has "destroyed" Father Hagan. It is Father Hagan, not the Cardinal, who is responsible for the consequences of his own actions. Yes, we are a Church of love and forgiveness, but it is not revenge to protect children from the risk of abuse. The legal system did not prosecute because of the statute of limitations. The protection of children is a present concern, however. It would have been irresponsible for the Cardinal and the Church to have acted otherwise.

I commend you for your 48 years of dedicated religious life as an Adrian Dominican Sister. I can appreciate the great sense of loss and emptiness that you must feel with what has happened at St. Denis Parish. But that does not justify the type of letter which you sent to the Cardinal. Given the Cardinal's terminal illness, your letter was, at least, insensitive. Moreover, for you to say that the Cardinal "destroyed" Father Hagan is insulting and offensive.

I believe you owe Cardinal Bernardin an apology.



I have always loved the Church but now I'm not so sure. In my 71st year of life and now having a distrust of church authority is frightening. As an Adrian Dominican Sister of 48 years, I have loved and labored with joy for a Church I believed was just, kind and merciful.

If you would take a moment to visualize the great loss of pastor, associate pastor, changing neighborhood and the emptiness of life, maybe you would be patient with me and answer my questions.

How can the destruction of a human spirit reward a 10 year allegation? Do 2 wrongs make a right? Isn't love and forgiveness more of the Church's teaching than revenge? Since the judicial system wouldn't be bothered with the allegations, why did the Process Team get so vehement in punishment? How can you ask a retired priest to baby-sit us and then uproot another man's life to fulfill a legal mentality.

If you would stop for a moment to humanly visualize inside St. Denis Rectory and see Fr. Jim's office stripped bare (like his life) and Fr. Bill's office empty. It feels colder than the morgue.

It doesn't help to tell me you are going to give us the "best you can muster up." We had the very best and you have destroyed him.

If for some reason, a change in an individual's schedule has been made, the resident is obliged to call in and update a staff member ASAP.**
- 4) Resident is required to call in two times each day, Monday through Friday in the AM TO [REDACTED]; Monday through Friday evenings at Koenig Hall, [REDACTED]  
[REDACTED] On Thursday evenings, Resident is to call in at [REDACTED]**
- 5) The Resident is not to take overnights, or be absent from the program unless prior approval is obtained from the Professional Fitness Review Administrator.**

- 7) Resident is to abstain from all illegal substances.**

resident's stay at residence. Such modification will be collectively determined by the Professional Fitness Review Administrator in conjunction with the Vicar for Priests. In case of emergencies, any staff member can modify this Protocol until an administrative decision can be made by the Professional Fitness Review Administrator.

- 9) In order to change this Protocol, prior approval must be obtained from the Professional Fitness Review Administrator.
- 10) This is a working document which can be changed, altered, or superseded when there is an indicated need to do so. A copy of this Protocol will remain on file at the Offices of Professional Fitness Review and the Vicar for Priests.
- 11) This Protocol will be reviewed no sooner than March 1, 1997. It will be reviewed again in September, 1997.



I have received your letter of June 21, 1996 in which you ask me to reach out to you as I have to the homeless, those dying of cancer, those torn by the tragedy of abortion or violence in the home. I will write to you as I do to them, with candor.

Let me begin by apologizing for any hurt, affront, injustice or disrespect you have experienced because of those of us you name "Catholic Church administrators." In their names, I ask your forgiveness. Forgive from your heart, [REDACTED], and now put the difficulty of the past behind you and move on. I hope you can explain to your children that you have taken the Lord's teaching very seriously: "I forgive all who have injured me and ask pardon of all I have injured." Your example will help your children now and for their difficult times in years ahead.

When I write to cancer victims like myself, I try to encourage them not to question the Lord's action in their lives but to place themselves in God's care. The tendency to ask "Why me?" is strong in all of us. The mystery of suffering demands very strong faith as response.

This letter is not going to try to explain or comment on every point you make in your letter. I do not have the facts to enable me to do that. I must say, however, that the allegations you reference about Father James Hagan must, by policy, be forwarded to the Vicar for Priests Office and to Bishop Conway, as you suggest.

Please put the past behind you by refusing to think of the injuries. I will pray for you and your family that peace of heart and mind may be yours.

On May 28 I had a long phone conversation with Fr. Bill Tkachuk. On that evening they were planning an evening service designed to deal with some of the needed healing of the parishioners and to commend the parish, Jim Hagan and others to the Lord in prayer.

In the course of conversation, Bill expressed a great deal of concern and described his personal determinations on how to respond to the pastoral concerns which were surfacing from the people. Many in the community have great affection for Jim Hagan and want to know more about him, his well-being and the procedures with which he is being handled.

Most recently a Lutheran minister spoke to some people about what he knew, which was not very much, and Bill in turn called the Lutheran minister and expressed his concerns that although there needs to be consideration for Jim Hagan there also needs to be concern for the victims.


In the course of conversation Bill mentioned that he had designed an item for the Parish Bulletin in which he wanted to acknowledge and thank people for their prayers and cards, which were being sent to Jim Hagan. This would appear in next week's bulletin. Bill agreed to FAX a copy of the article to us here. Pat O'Malley and I looked at the article and the first few paragraphs were very good and were right on the mark but we had some objections to the third paragraph because it used the word "rumors" and we thought that the whole last paragraph did not quite fit with the others and if rumors were going to be addressed it was better to use the language of questions and concerns.

Late on Tuesday, May 28, I got in touch with Bill Tkachuk again and told him of our concerns. It was his judgement that it was best to address the article as written and perhaps it was too late for any revision.

In turn I asked him how the evening of prayer was received. Bill described it as a service of evening prayer with the rosary,

about 200 persons attended.

In the structure of the rosary each decade was announced for a specific intention. The first was for Jim Hagan himself, the second was for young people who may have been victims, the third was for the parish, the fourth was for abuse in everyone's own lives and the fifth was for all the professionals who are involved in such matters. Bill described a reception afterwards where people talked to each other and talked very freely. Everyone was of the mind that such public prayer was very helpful. It calmed everyone. It had a deep and personal effect. The public prayer was a way of focussing individuals' personal prayer. In the course of conversation Bill found himself commenting not only on the public prayer but also stating that there was no intention of manipulating or re-directing anyone's individual or personal prayer. In the end, people were stating that perhaps they should meet monthly for such a prayer service. Bill said that he would wait to see whether this was an invitation that came from a number of people or just from one or two.



On Sunday, June 2, I tried to reach Jim Hagan at Koenig Hall to express my concern about him. He had just left to visit his mother. I asked that he call me the following day.

On Monday June 3, I spoke with Hagan. He in turn informed me that he has been in touch with [REDACTED] After some delay and another contact with [REDACTED] office the raw data was finally forwarded.

On Monday June 10, Jim Hagan informed me that his mother suffered a rather serious stroke. They do not know yet the extent of the

damages. [REDACTED]

Later today I spoke with [REDACTED] ( her pager is: [REDACTED] ) As they prepare a substantial program for JH, she asked if I thought that they might interview any alledged victims. I told her that I have not met them nor do I know them. I had been told however that they were close friends and desired to remain anonymous. But I said I would confer with Ralph B and get back to her.

The protocol and the task for Ralph [REDACTED] [REDACTED] were reaffirmed with Ralph B on the phone on Wed. June 12.

At the convocation Tom Dore talked to DC again about another possible victim. DC again encouraged Tom to urge the man to come forward so that the church could help this person. This would not necessarily change JH's situation with the FRD. Ralph was also informed that this may all happen. I encouraged that Ralph and Bernadette meet with the man. The Vicar's office would say out of this and there was no reason to put the man thru this more than once before help could be offerd to him.

On June 17 we were informed that the family was not disposed to allow JH to celbrate any public service for his mother. If she were to die they can only imagine a "private ceremony".

Ralph was told of [REDACTED] request. After some discussion he

and I decided that the timing was not good for the Archdiocese to give [REDACTED] their names or draw them into anything not of their design for our sake or for JH's sake.

I contacted [REDACTED] and told her this. She still hopes that in the future there might be the opportunity to interview even anonymously. I encouraged her to speak to Bernadette since BC asks about force in her interviews.

At the Cardinal's anniversary celebration on May 8, Fr. Tom Dore approached me with a matter he had hinted at over the phone. Over the phone he did not feel free to talk about the matter.

Tom told me that he had been contacted by a parishioner who he knew from years ago at St. Catherine of Siena parish. Tom knew that this person was also a friend of Jim Hagan. This man, now [REDACTED], said to Tom that he could understand what had recently been in the media regarding Jim Hagan. On a single instance, he had had to fight off Jim Hagan himself.

In the course of describing the conversation, Tom mentioned that this young man [REDACTED]

I suggested to Tom that he contact the young man again and tell him that the Archdiocese is concerned about him. It is obvious that Fr. Hagan is already being taken care of, but if he were to come forward and make himself known to the Archdiocese, we could afford him every help, pastoral or psychological, to heal any wounds inflicted in the past. I told Tom he could give him my name and phone number or that of Bernadette Connolly or of Ralph Bonaccorsi. Tom seemed to understand our commitment to helping victims. Tom said that he was also concerned and would do his best to convince the man to seek help.

On May 14 I again had a conversation with Tom Dore. He assured me that he had contacted the man in question and had encouraged him to talk to Bernadette Connolly or me. Tom thought that at present he would not come forward because he did not want to bring more of the past into the present. I encouraged Tom to wait a while, perhaps a couple weeks, and then again reach out to the man personally to see if he could be of any pastoral assistance to him and to again assure him of our concern and our desire to assist him in any way we can.

On April 24, [REDACTED], it was learned that Mary Ann Ahearn was asking questions as to why Fr. Hagan was no longer at St. Denis parish. Within minutes the two-minute drill went into effect and all proper persons were notified and the time table that had first been enunciated out of care for the victims had to be ammended as we pressed ahead, targeting basic parish information for Sunday, April 28.

On Thursday, April 25, I met with Jim Hagan at the Cardinal Stritch Retreat House. We had a very open and cordial conversation. He seemed well disposed toward making his first step [REDACTED].

On Sunday, April 28, I was in touch by phone with Fr. Bill Tkachuk, presently the administrator of St. Denis parish. Bill told me that Jim Hagan had told him the names of the two families involved. Bill in turn informed Ralph Bonaccorsi that he knew of these two families and assured Ralph that it would go no further. Also, he wanted Ralph to tell the families that he knew from Jim Hagan that they were involved so that he could be of pastoral help to them if and when they needed it.

Bill assured me that he would be receiving and sending all messages to Jim Hagan himself.

Jim Hagan has called him and talked to him. They seem to have a strong relationship. This is helpful for the parish at this time. The Sisters from the parish have visited Jim Hagan's mother.

The people of the parish seem curious as to the circumstances in which Jim Hagan now finds himself. Their concern is for him. Many people will not accept the fact that he has done wrong.

Jim Hagan was invited to return to Chicago and to again live in his monitored situation following his strict protocol.

We agreed to have a further conversation about his things and finances, especially as these impact on his mother and St. Denis parish. We agreed to have this conversation after he returns to Chicago.

On Saturday, May 4, I called Bill Tkachuk. Pat O'Malley and I helped him address some of his pastoral and personal questions. These had to do with people's questions in the parish, with Jim's belongings and with future possibilities. Bill seemed satisfied with our answers. He also will be seeking the help he needs as he responds to this challenging pastoral situation.

I know, Jim, that this time has been very painful and difficult. Thank you for discussing this decision with Father Dan Coughlin and for your gracious letter to me. It is my hope that the inner peace you have found will remain with you in the months and years ahead.

The official process to change one's canonical status from cleric to layperson involves seeking dispensation from the obligations of priesthood through laicization. In order to initiate such a process, you should speak with Father Emmett Gavin, O.Carm. He can be reached at 312-751-8211. I am sure you will find him most helpful.

Be assured of my deep appreciation, Jim, for having given over twenty-two years of service in the Archdiocese. No doubt, your ministry and presence were of significant help to many people.

Know of my encouragement and prayers.

As you were informed yesterday by Bernadette Connolly, Professional Fitness Review Administrator, allegations of clerical sexual misconduct with minors have been brought against you. After she met with you and your attorney, the Professional Fitness Review Board met last evening. The Board determined that there is reasonable cause to suspect that you engaged in sexual misconduct with minors. Cardinal Bernardin accepted this determination and the Review Board's recommendations, as follows:

Out of concern for your own welfare and that of the Church, you are hereby placed on administrative leave of absence from ministry. During the period of this leave, you are required to absent yourself from St. Denis Parish.

You are to go immediately to stay at Koenig Hall of the Cardinal Stritch Retreat House in Mundelein, Illinois. [REDACTED]

During this period of administrative leave, it is understood that you are not to exercise public ministry nor represent yourself publicly as a priest. You are not authorized to act as an agent or representative of the Archdiocese of Chicago.

You are not to be alone with any minor without the presence of another responsible adult. Moreover, you are not to have any contact with the [REDACTED]

Jim, I know that this is a difficult time for you and for all the concerned parties. Please be assured of a special place in my prayers. I encourage your full cooperation with these actions.

I want to set your mind at ease a bit. You undoubtedly know that the Cardinal recently appointed a commission to review all cases of alleged or real child abuse in our archdiocesan records. We presented to the commission every case that has come to our attention in the past thirty years.

One of those cases was the situation in which you were involved in May of 1988. When we presented the facts, the commission agreed with our assessment and our handling of the incident. They also agreed that there was no need for action at this time. As far as they were concerned, the incident is closed.

While it is always painful to bring that incident up again, I felt you might well be worried as to whether it had been considered by the commission.

Not to worry. We can put it away for good now. If you want to pursue this matter any further, don't hesitate to call. But, as I said, I'm now going to place the file on the inactive list.

I hope things are going well with you, Jim, and I hope this Advent season will be a fruitful and expectant one for you and your people.



2. While Jim and I were discussing, Jim Hagan called quite upset about a turn of events. He said that one of the parishioners, a [REDACTED], who is the mother of one of the children in school, called him about another parishioner, [REDACTED] who had received a call from a Marlin Daniels, who said that he was from Catholic Charities, the Department of Children and Family Services.

3. I asked Jim to clarify that, as either Daniels worked for Catholic Charities or he worked for DCFS, but he wouldn't be employed by both. Jim Hagan really didn't know who he worked for, but the impression he got was that he was employed by Catholic Charities. [REDACTED] was very upset because Daniels was asking her about possible child abuse and she did not feel that either she or her child was a victim or that Hagan was a perpetrator. But the whole conversation upset Jim Hagan very much.

4. I told Jim to stand by and I immediately called Ed Conway at Catholic Charities. Ed checked their computer and said that there is no such employee by that name nor has there ever been. Ed then checked it out further and found out that [REDACTED] was called by DCFS this morning around 10:00. Apparently Daniels works for DCFS and Ed will check this out. Ed subsequently told me that [REDACTED], who is one of [REDACTED] superiors, did indicate that she knew Marlin Daniels and said that he was a pretty good case worker.

6. I called Jim Hagan back just to pass along this information and to re-assure him. He was quite distraught and very appreciative of all the help he was being given. I told him to sit tight until we have an answer from DCFS.

Jim Hagan called today. He and Bill Kenneally have talked over all of this and Jim came up with something that may be of help. He said that ordinarily they would use a screen in the reconciliation room so that the children would have the option of going behind the screen or face to face. Jim recalled that the screen broke during the last series of confessions and so the last three grades would have had to go face to face with no option. Jim mentioned this, because when he was here to see me he did state that the screen would have been there. Jim also feels sure that he said something to the children that if they wished to go anonymously, they should go to Fr. Kenneally in the regular reconciliation room.

Jim was obviously disturbed at all of this and said that he had a very rough weekend. Although I was going to wait until he had finished his meeting with Jim Serritella, I thought I should put him at ease and let him know that my interview with the girl and her mother on Saturday morning convinced me that there was nothing to the charge of child abuse. I told him that he will probably have to modify his style of offering the sacrament of reconciliation, but that there was no evidence to point to any sexual intent on his part. I also told him that neither the daughter nor the mother intend to pursue this, as the child's mother seems satisfied that all the necessary steps have been taken and that there was not, in fact, any sexual exploitation or child abuse involved. I will call Jim again after I hear from Jim Serritella.

After further inquiry into the allegations of sexual misconduct with minors against Father James Hagan, Pastor of St. Denis Parish, 8301 South St. Louis Ave., the Professional Fitness Review Board conducted a Second Stage Review on Wednesday, August 21, 1996. The Board recommended that Father Hagan's withdrawal from ministry continue. Cardinal Bernardin has accepted this recommendation. Following this decision, Cardinal Bernardin has accepted Father Hagan's resignation as pastor of St. Denis Parish.

This Second Stage Review was conducted in keeping with Archdiocesan policies and procedures, which provide that such a review shall ordinarily be initiated and scheduled to occur no earlier than 30 and no later than 120 days after completion of the First Stage Review. Father Hagan's First Stage Review was completed on April 22, 1996. Father Hagan has been on administrative leave since that time.

Cardinal Bernardin has expressed his concern for Father Hagan, for those who brought the allegations, and for all the people of St. Denis Parish. He acknowledged that this is a time of grief in many respects. Mindful of the pain and hurt being felt at this time, the Cardinal expressed his hope that true peace and healing may come to all involved in this process.

According to the Postal Service documentation that we received, on Saturday, July 10, 2010, James C. Hagan received the canonical notification of his return to the lay state, that is his laicization. The letter informing him of his laicization also asked that by July 29, 2010 he contact either me or Deacon Dan Welter to sign the decree of laicization; he never contacted us.

Pursuant to that:

1. Both original copies of the Decree will be signed by Cardinal George and notarized by Jimmy Lago.
2. One original will be returned to the Congregation for the Doctrine of the Faith and the other original will be filed in James C. Hagan's Chancery file.
3. Access to the signed original of the Rescript in his Chancery file should be done through the Chancellor.
4. The effective date of the laicization is April 23, 2010, the date that the Holy Father decreed his laicization.
5. In accord with Canons 535, §2 and 1054, a request has been sent to the parish of his baptism asking that the entry that records his baptism now also note his return to the lay state and his release from all the corresponding obligations, including that of celibacy. The parish has been instructed that whenever a certificate attesting to his baptism is issued, there is not to be any mention of his ordination as a Deacon and a Priest, not should there be any mention of the obligation of celibacy.
6. Any inquiries about his return to the lay state should be referred to the Chancellor of the Archdiocese of Chicago. In the letter to his parish of Baptism, it was requested that this also should be noted in his baptismal entry.





[REDACTED] said that it was in seventh grade when Fr. Hagan would have movie nights in the rectory. He spoke of the movie nights in Fr. Hagan's room including [REDACTED]

[REDACTED] said that Fr. Hagan would fondle whoever he was sitting next to at the movie nights. He continued by saying that Fr. Hagan would feel him up over his clothing and fondle his genitals. When asked, [REDACTED]

[REDACTED] said that "the gang" included a specific group of kids [REDACTED]

[REDACTED] stated that Fr. Hagan also took him and the other boys to the movie theater. He remembers no one wanting to ride in Fr. Hagan's car. When asked, [REDACTED]

[REDACTED] said that Fr. Hagan also abused him in the car in the same manner as already described, fondling his genitals over and under clothing. [REDACTED] estimated that there were between five and 10 incidents of fondling by Fr. Hagan in the cleric's car.



Today, at about 1:30 p.m. I received a telephone call from a woman who identified herself as [REDACTED]. She stated that she had been trying earlier today to contact the CAIR office, but the phone numbers she found on the website proved to be disconnected. [REDACTED] stated that she then called the main OPCY number, at which point Carolyn Perz connected her to me.

[REDACTED] stated that she had a friend who recently disclosed that he was sexually abused as a child by Fr. James Hagan at St. Richard's. She estimated that the alleged abuse took place some time between 1980 and 1983. [REDACTED] stated that her friend is a 43-year-old male. I explained to [REDACTED] how the Assistance Ministry process and the CAIR process work. She thanked me and told me that her friend would be calling me directly later this afternoon.

At about 3:00 p.m., [REDACTED] called back and stated, "Matt, it's [REDACTED]. Here he is." A man then began speaking, identifying himself as [REDACTED]. He stated that he was sexually abused as a minor by Fr. James Hagan. [REDACTED]



On October 30, 2008, I spoke to [REDACTED] regarding the Archdiocesan process for formalizing his allegation against “Fr. James” [Hagan]. *Note: [REDACTED] did not identify the priest in this telephone conversation.* During the call:

- I clarified that supportive services from the Office of Assistance Ministry are available to him and his wife, [REDACTED] even before he formalizes his allegation with the Office for Child Abuse Investigations and Review.
- I briefly described the intake process, and informed him that he could bring someone of support with him to the meeting, if he so wished.
- [REDACTED] was concerned that he would not be able to remember all he wanted to report. I assured him that he would have an opportunity to add his own notations to the written report once he receives it.
- When asked, I informed [REDACTED] that his report would be shared with specific internal archdiocesan personnel (e.g., the Cardinal, the Vicar for Priests Office, etc.) as well as with the State’s Attorney. He said he understood.
- [REDACTED] shared his anxiety about not fully understanding the Review Board Process. I encouraged him to call Leah McCluskey so that she could speak more specifically about the process. I provided him with her contact information.

I was very upset to hear the allegations re. Father James Hagan. In 1988 several mothers from St. Gertrude's (17) called [REDACTED] at St. Gertrude's to complain about Father Hagan rubbing their daughter's legs in face to face confession and putting his hands very high up on their legs under their skirts. The girls were especially upset when Fr. Hagan then was selected to teach them sex education in a room with just the girls and with the door closed. There were complaints made to the principal who was not cooperative. As I was not the parent of a girl I heard that when the moms planned a meeting to discuss this the pastor broke up the meeting and said it would look bad for the parish. [REDACTED]

[REDACTED] My son agreed to tell his story to DCFS and the police as did one brave young woman. The other girls took back their stories after the pastor approached their mothers. I called to complain to [REDACTED] who said he would believe [REDACTED] over me any day as [REDACTED] was his friend.

I was very upset to hear Hagan was reassigned to St. Denis especially after that school had experienced molestation by a science teacher that same year. I talked to [REDACTED] and voiced my dismay.

I know that the Archdiocese must be aware of this. Why did you allow him to go to St. Denis? I had better hear soon that you are acknowledging this or I will have to go to the media. This is incestuous and very very sad. In 1988 I told the Archdiocese they had better watch him and if anything else happened I would go public. I will or ask the students to do so. If even one St. Denis student comes forward let it be on your conscience. I pray you will make the correct decision.

JERRY BOLAND MET WITH THE COMMUNITY OF ST. DENIS ON MONDAY, SEPTEMBER 23.

**Staff Meeting:** At the meeting conducted with the parish staff, the staff described St. Denis as a parish that is still grieving the loss of their pastor James Hagan. There are also a fair amount of feelings regarding the process that led to this decision. The staff and parish leadership have been dealing very deliberately with this. People are in a better place than where they were at. A number of positive things have surfaced out of this experience. In addition to a sense of loss regarding the pastor, some people are disappointed that Fr. Bill Tkachuk is also leaving. In the larger community there is a fair amount of ethnic and racial change going on. A number of parishioners feel a sense of abandonment. The parish has been blessed with a strong and credible lay leadership presence, and prides itself on the spirit of hospitality. The parish council has been very effective. It hopes to become a more active agent in welcoming new members into the community. Evangelization is critical. In terms of a new pastor, people hope that it is someone who is sensitive ... a people person ... someone able to delegate ... someone who values liturgy and is a good preacher. The new pastor must take on an attitude of assisting the community in moving forward. They want someone who will be happy to be here ... someone who will be willing to be present to the community ... someone who is supportive of the parish's outreach in terms of community organization.

Jerry Boland and Bishop John Gorman conducted the town hall with the parishioners in the evening. (About 150 people were present.) The meeting was positive and honest. The people have felt the pain of a lot of change, they want to take a more positive approach to new members moving into the community. In addition to African-Americans, there are a growing number of Hispanics and a growing number of Filipinos. The Board was presented with about 100 petitions from Spanish speaking parishioners expressing their hope that the new pastor encourage and foster efforts to reach out to the Hispanic community. Many of the Hispanics are going to other parishes because not much is going on at St. Denis for them. Parishioners spoke about the importance of the school, the importance of liturgy. They want: a pastor who will work in partnership with them, someone who is able to delegate ... to see a pastor who will really assume the mantle of spiritual leadership ... they want and hope for a pastor who is willing to invest in the community and call St. Denis home.
